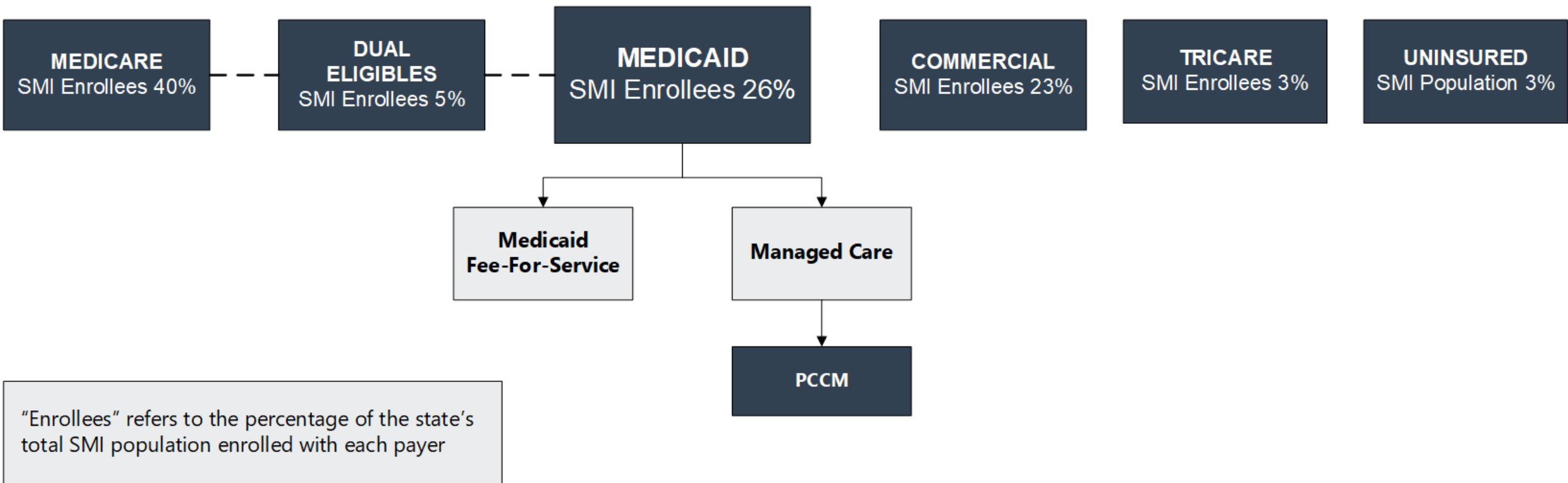

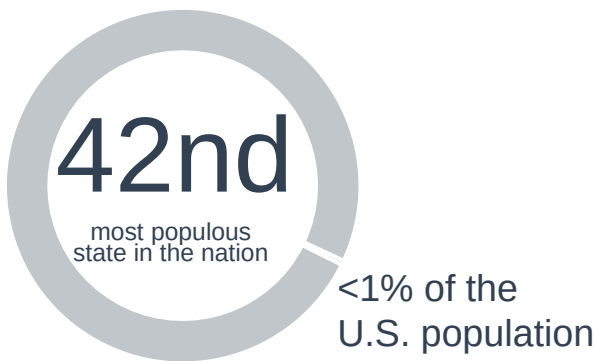

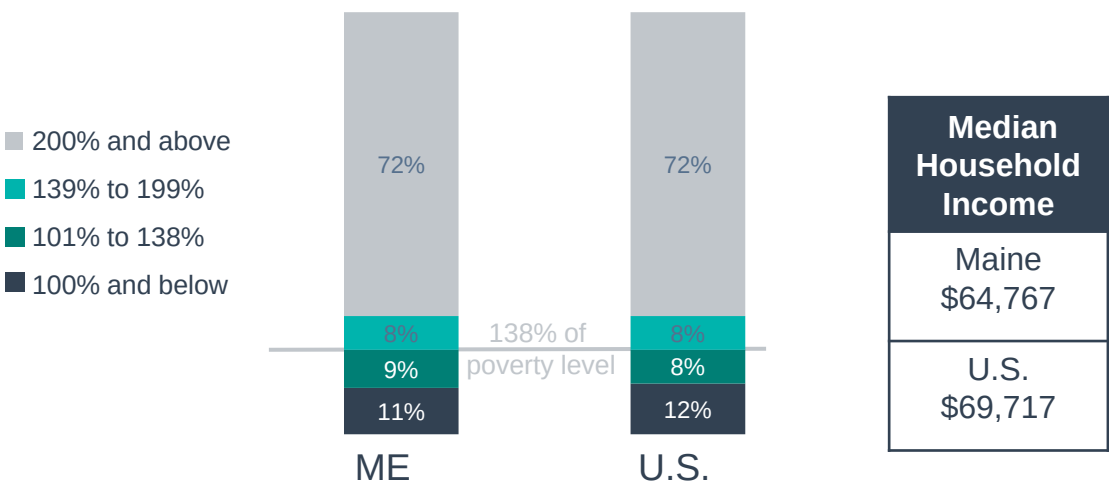

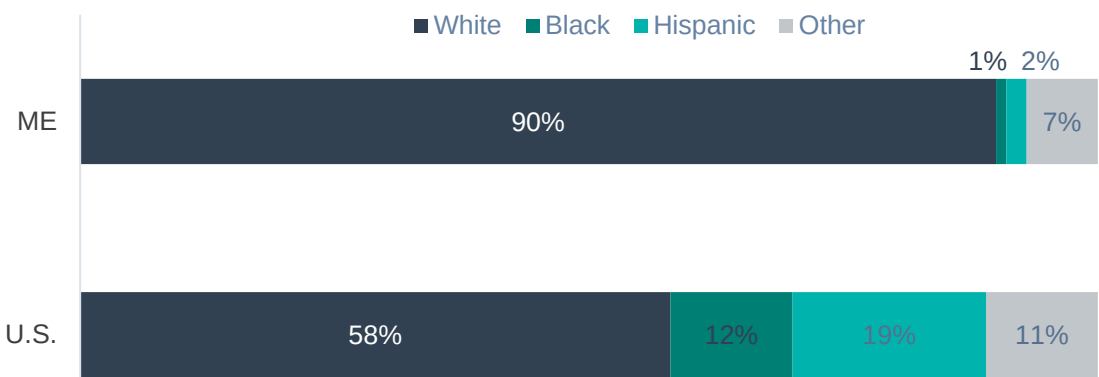
Population Distribution By Income To Poverty Threshold Ratio



Population Distribution By Age

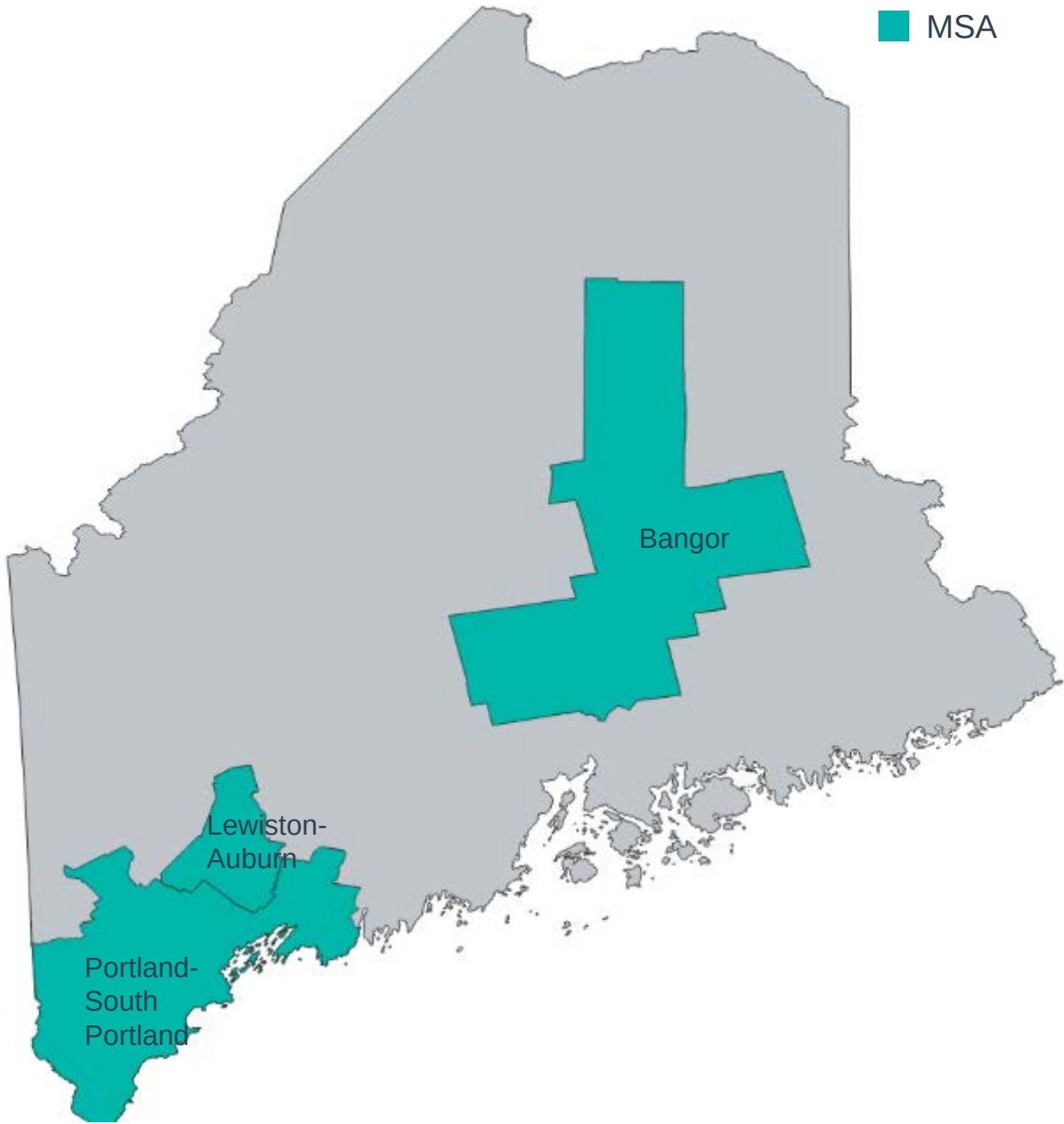


Maine & U.S. Racial Composition

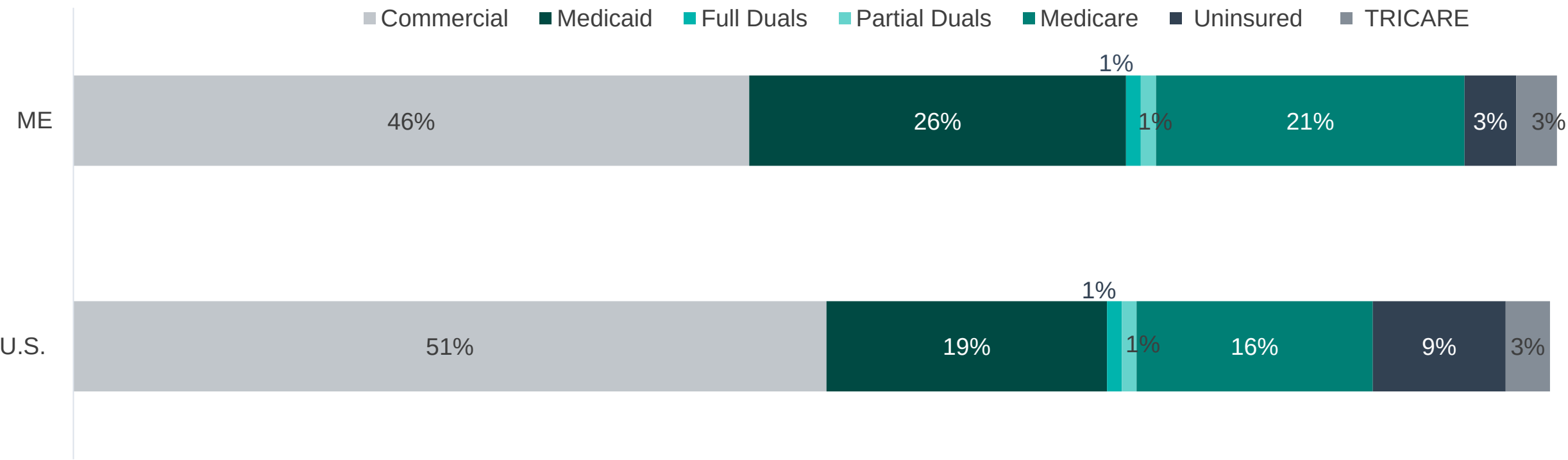

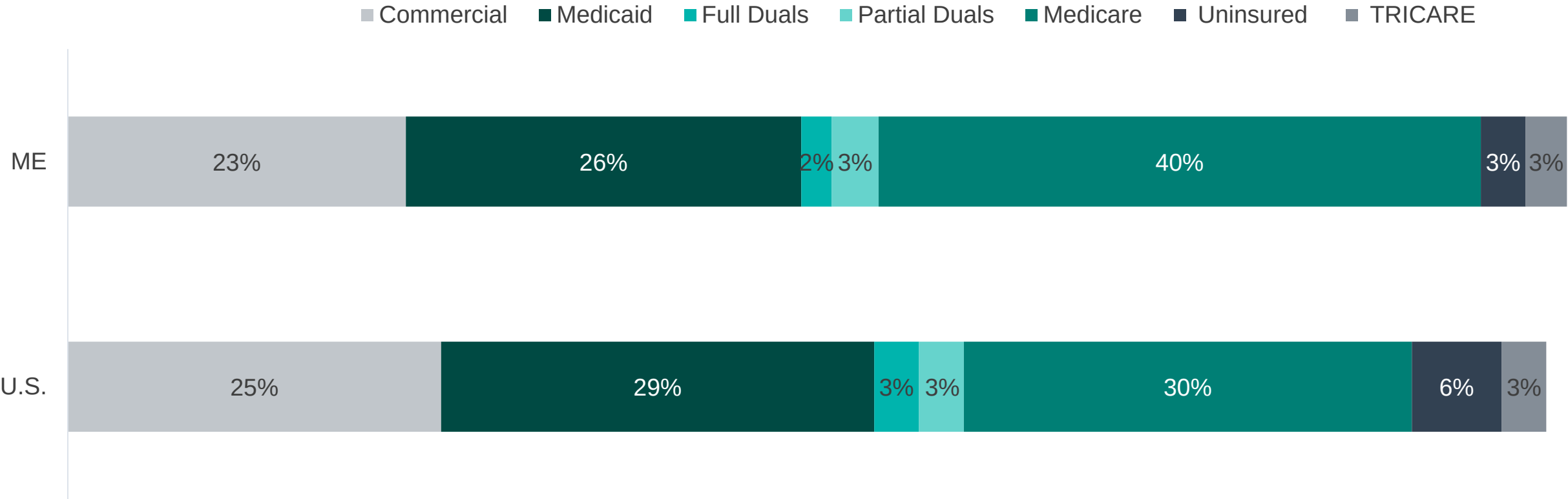

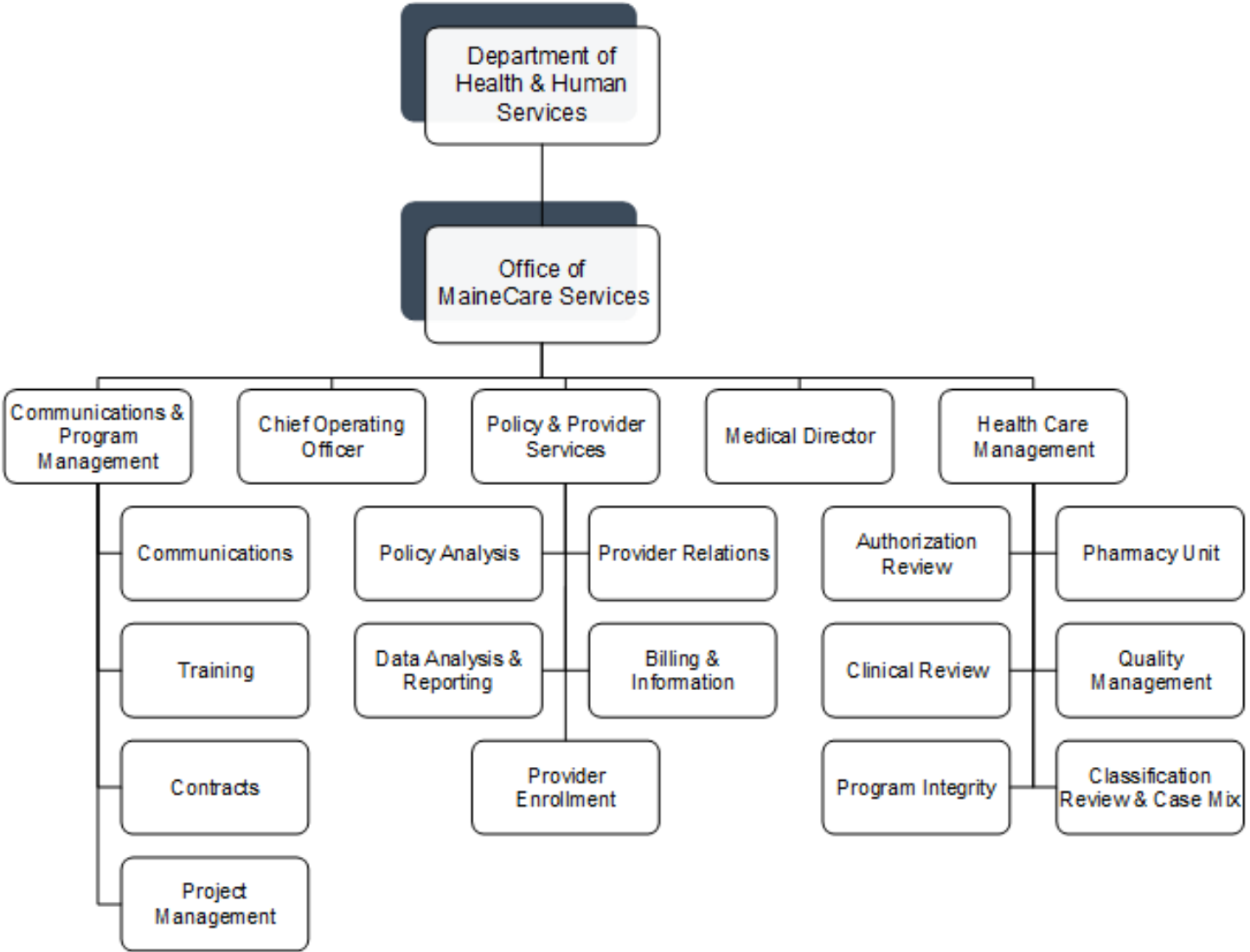

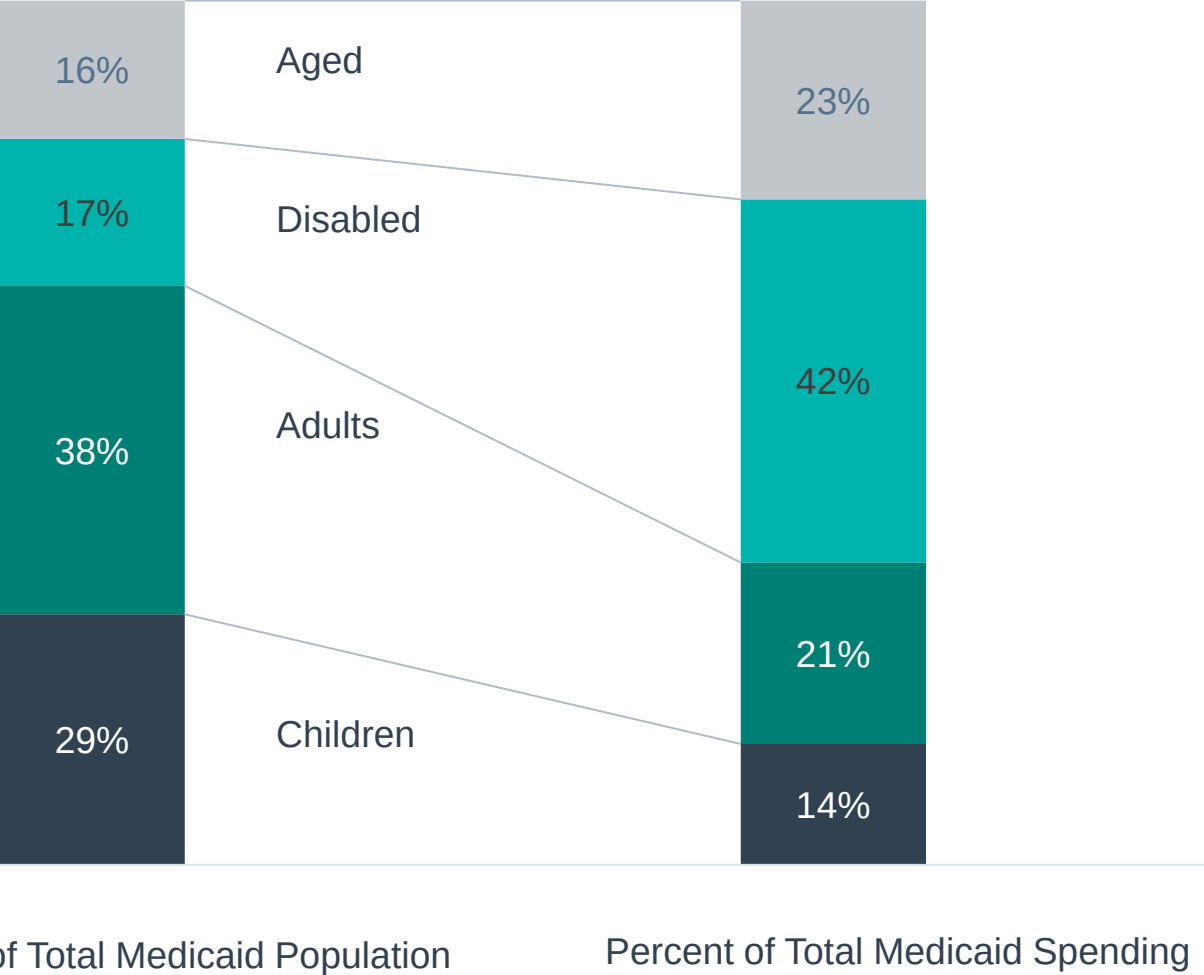

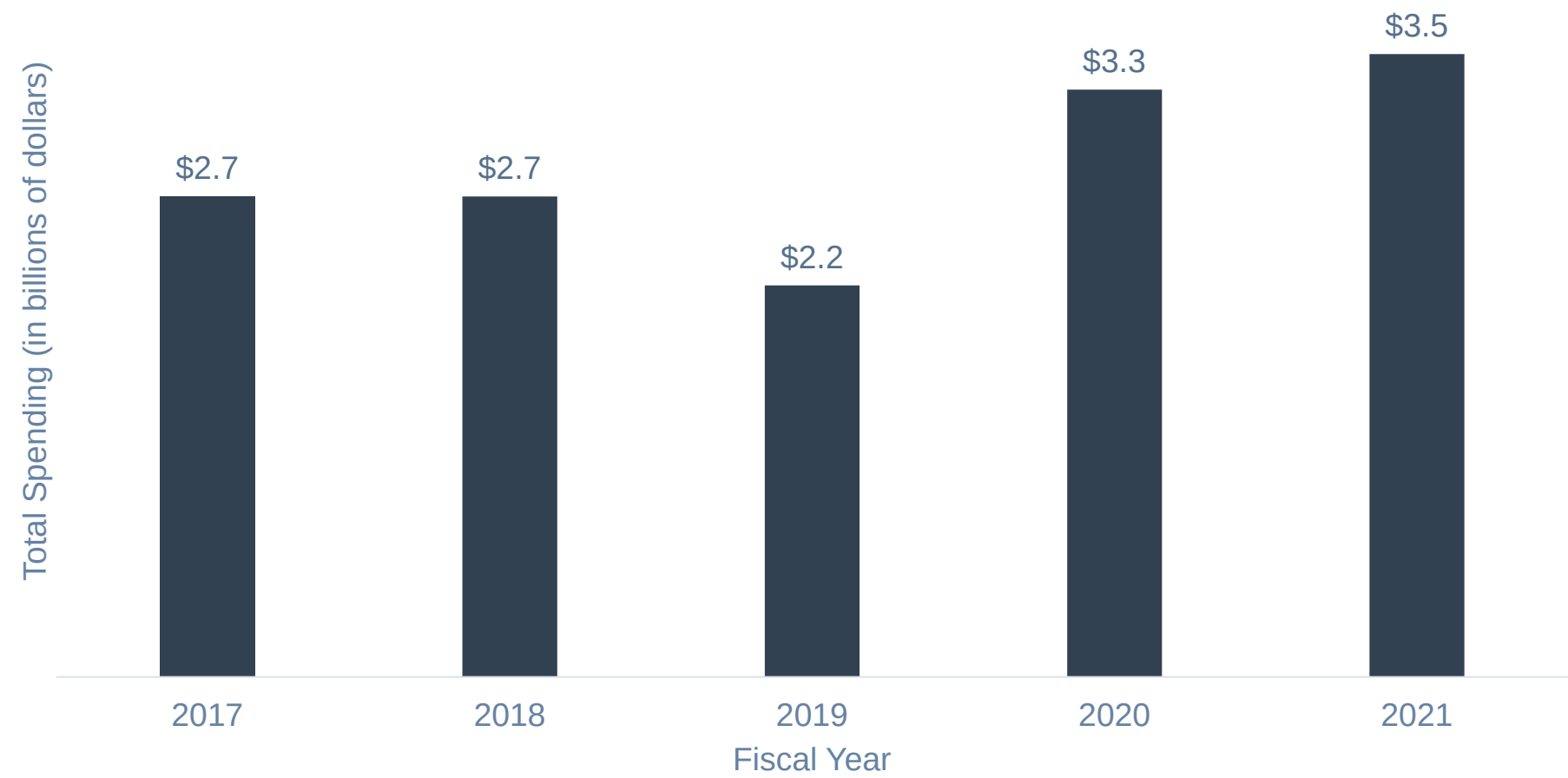

D.3. Medicaid Managed Care Program: Overview

- *OPEN MINDS* estimates that managed care enrollment as of March 2023 was 46,168.
- Primary Care Plus (PCPlus) is MaineCare's new value-based approach to support primary care. PCPlus replaced Primary Care Case Management, Primary Care Incentive Payment, and primary care Health Homes with a single, integrated initiative and offers primary care practices greater flexibility and incentives to meet MaineCare members' health care needs.
 - Primary care physicians act as “gatekeepers” to specialty services.
 - Primary care provider organizations are paid a fee of \$3.50 PMPM for care coordination.
 - Medical services are reimbursed on a FFS basis.
- Primary care provider organizations may receive additional compensation of 30%-40% of the bi-annual reimbursement through the Primary Care Provider Incentive Payment (PCPIP) by scoring above the 20th percentile for PCPIP quality indicators ([see next slide](#)).
- The goals of PCPIP are to reduce the number of unnecessary emergency room utilizations, increase the use of preventive services, and increase access of MaineCare members to clinical professionals.
- The state also contracts with accountable care organizations (ACOs) to serve the state's PCCM population called Accountable Communities.

D.4. State Medicaid Program Care Coordination Initiatives: Accountable Communities

- Accountable Communities are Maine's version of ACOs for the Medicaid population. The program was implemented in August 2014.
 - As of March 2021, 111,166 members received services through the Accountable Communities.
- The Accountable Communities initiative was originally approved as a three-year program. On November 6, 2018, the state submitted a state plan amendment to extend the program for three additional years.
- The state contracts with lead entities, who in turn contract with other provider organizations. Lead entities can be provider organizations or organizations that contract with provider organizations.
 - Each Accountable Community must directly provide primary care services, meet PCCM requirements, and include at least one chronic condition, one developmental disability, and one behavioral health provider organization.
- Savings and losses are calculated by retrospectively comparing actual total cost of care to the benchmark total cost of care. The benchmark cost of care includes physical and behavioral health services. Accountable Communities have the option to include institutional care and home- and community-based waiver services in their benchmark costs. There are two models that Accountable Communities may utilize:
 - Model I: Minimum of 1,000 members; savings must meet or exceed 2.5% based on performance of defined quality benchmarks for the performance year
 - Model II: Minimum of 2,000 members; savings must meet or exceed 2.0% based on performance of defined quality benchmarks for the performance year
- Members may be attributed to an Accountable Community based on six months of continuous eligibility or nine months of non-continuous eligibility, health home participation, number of primary care visits, or emergency department visits at an affiliated hospital.
- The state reported that the program achieved a total of \$6.75 million in savings in year four, \$975,510 of which was shared with the Accountable Communities. Year Five achieved a total of \$4.02 million in savings, \$782,812 of which was shared with AC's. Year Six and Year Seven have not yet been calculated as of June 2021.

D.6. Medicaid Program New Initiatives: Maternal Opioid Misuse Initiative

- In 2020 Maine was awarded \$5.3 million to participate in the Maternal Opioid Misuse (MOM) Model. The MOM model provides pregnant and post-partum women that have opioid use disorder with treatment and recovery supports to reduce the number of infants born with drug-related addictions. The grants will last for five years.
 - Contract awards were granted in January 2020. The program began offering services July 1, 2021. Although funding will end after 5 years, MaineMOM services will continue after December 2024.
 - Maine is required to partner with one or more care-delivery partners to deliver physical and behavioral health care services. Care-delivery partners are required to provide screening, treatment, referrals for critical wraparound services, referrals to community or other support services, and beneficiary engagement services.
 - The state has chosen MaineGeneral Medical Center, Maine Health, Mid Coast-Parkview Hospital, Northern Light Health, Penobscot Community Health Care, Pines Health Services for the program. As the program progresses, Maine intends to add additional sites.
- DHHS is working with the Center for Medicare and Medicaid Innovation (CMMI) to implement the MOM model.
 - For the first year, or the Pre-Implementation period, DHHS will develop and prepare the model.
 - For the second year, or the Transition period, CMMI will be financially responsible for treatment services that are not covered by Medicaid.
 - For years three to five, or the Full-Implementation period, all services will be included in the care-delivery model and covered by the State's Medicaid program. The state may explore performance-based payments at a later date.
- Maine is currently working on legislation to transfer from using the federal health plan marketplace to a state-based marketplace.

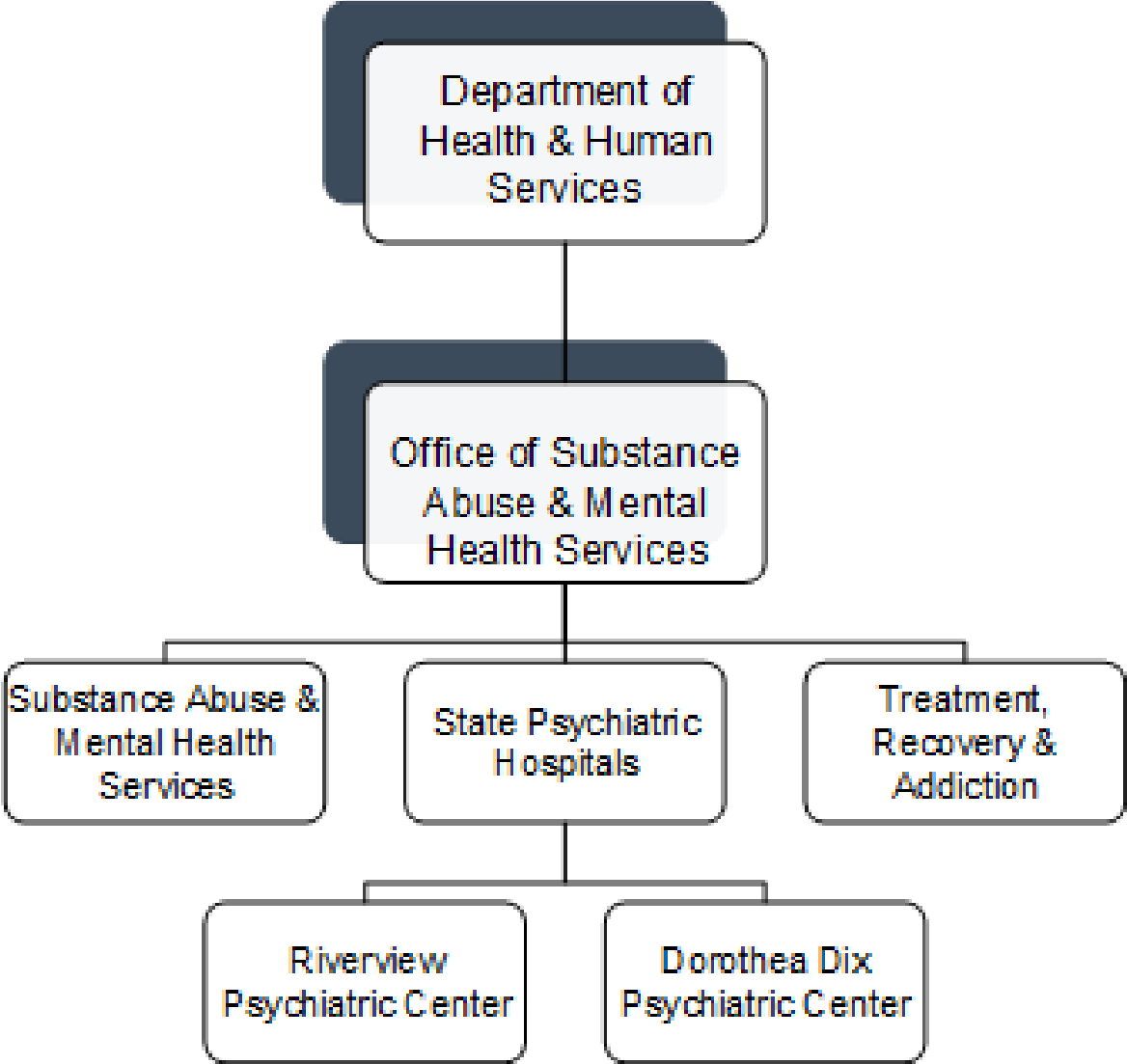

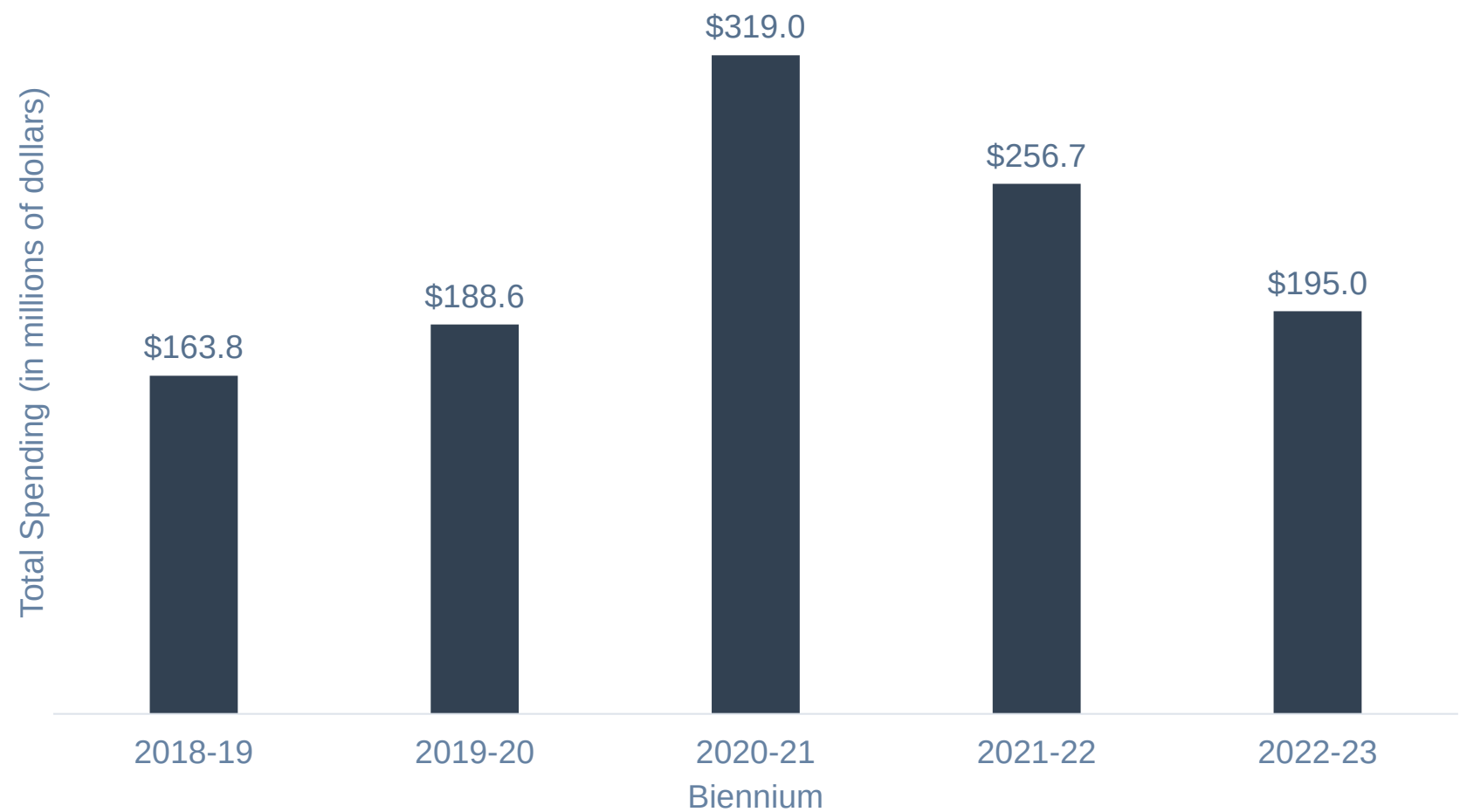

G.4. Behavioral Health Safety-Net Delivery System

- The Office of Substance Abuse and Mental Health Services (SAMHS) within DHHS provides mental health and addiction treatment services to the uninsured population through a network of provider organizations.
- Uninsured individuals receive referral to treatment services by contacting the DHHS office in their area.
- SAMHS treatment services include:
 - Crisis intervention services
 - Residential treatment services
 - Shelter services
 - Case management
 - Behavioral health homes
 - Supported employment services
 - Medication management and medication assisted treatment (MAT) services
 - Ambulatory detoxification services
 - Outpatient and intensive outpatient services
 - State forensic evaluations
 - Recovery support services
 - Peer supports

G.4. Behavioral Health Safety-Net Delivery System

- In the summer of 1989, poor conditions at the Augusta Mental Health Institute (AMHI) contributed to the deaths of ten individuals. AMHI closed in 2004 and was replaced by Riverview Psychiatric Center. A subsequent class action lawsuit resulted in the AMHI Consent Decree Settlement Agreement Plan of 2007.
- The plan requires the state to provide the following services to individuals with SMI in order to prevent psychiatric hospitalization, or to facilitate transition to community living:
 - Individualized support plan (ISP)
 - Community integration and community support services
 - Housing and residential support services
 - Crisis intervention services
 - Treatment services
 - Family support services
 - Vocational employment services
 - Transportation
 - Access to recreational, social, avocational, and spiritual opportunities
 - Access to medication assisted treatment
- Individuals gain access to consent decree services by applying through the Department of Health and Human Services or one of its contracted agencies. The state is required to assign a caseworker to each individual within seven days of application.

Fee-For-Service	FFS	A system where the payer, in this case Medicaid, contracts directly with provider organizations and pays for providing care on a unit by unit basis. Health plans may also reimburse provider organizations on a FFS basis meaning they pay for each unit of care or test.
Health Home		A “whole person” care coordination model that specifically targets populations with chronic conditions including those with SMI. Health homes provide six essential functions: 1.) Comprehensive care management; 2.) Care coordination and health promotion; 3.) Comprehensive transitional care from inpatient to other settings, including appropriate follow-up; 4.) Individual and family support; 5.) Referral to community and social support services; 6.) Use of health information technology to link services. Health homes were originally developed as a Medicaid program, but have been adopted by other payers. For a state to have an official health home program they must have an approved state plan amendment.

In recent years, CMS has relaxed the rules prohibiting payments in IMDs for individuals ages 21-64. Medicaid health plans may provide up to 15 days of IMD services per month in lieu of state plan services if medically appropriate, cost effective, and consented to by the individual. Additionally, states may be granted a 1115 waiver authority to allow individuals to receive addiction and mental health treatment in IMDs.
Long-Term Services & Supports	LTSS	Services provided in the home, community, or institutional setting to those who experience difficulty living independently and completing activities of daily living as a result of cognitive disabilities, physical impairments, disabling chronic conditions, and/or age.
Managed Care		A health care delivery and financing system designed to manage cost, utilization, and quality. In Medicaid, states generally implement managed care through contracts with health plans, which provide a limited set of benefits to enrollees through a capitated or per person per month (PMPM) rate. The health plans generally assumes full-risk for the cost of treatment, and therefore contracts with a network of provider organizations to provide care at the most efficient rate possible while still maintaining member health.
