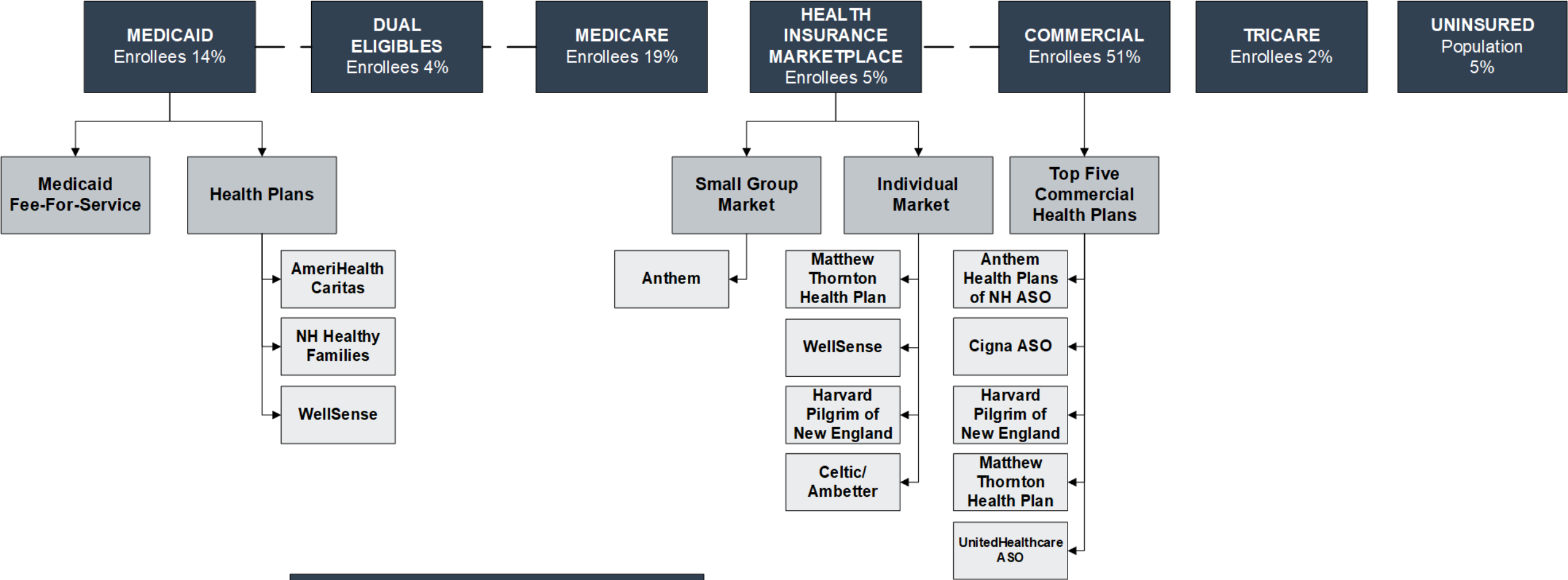

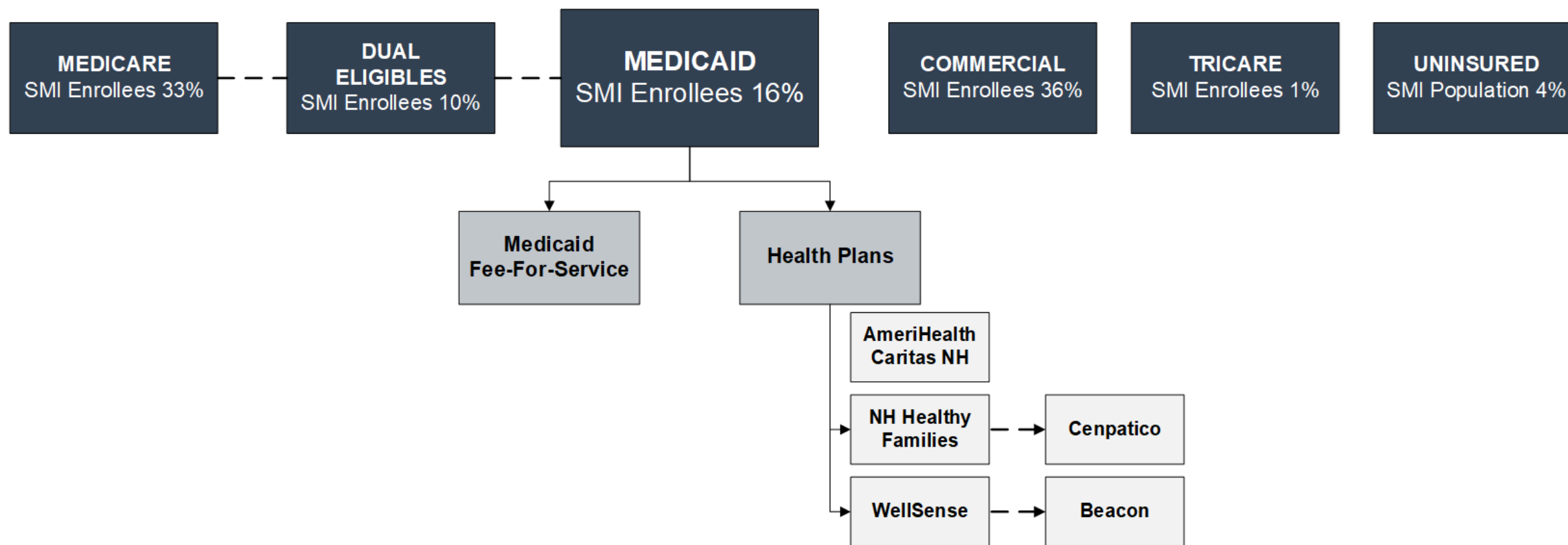

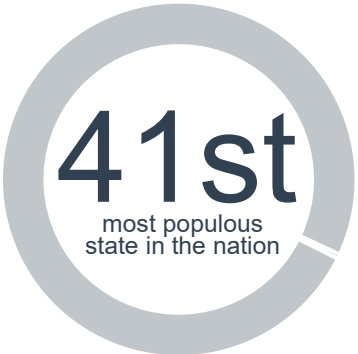

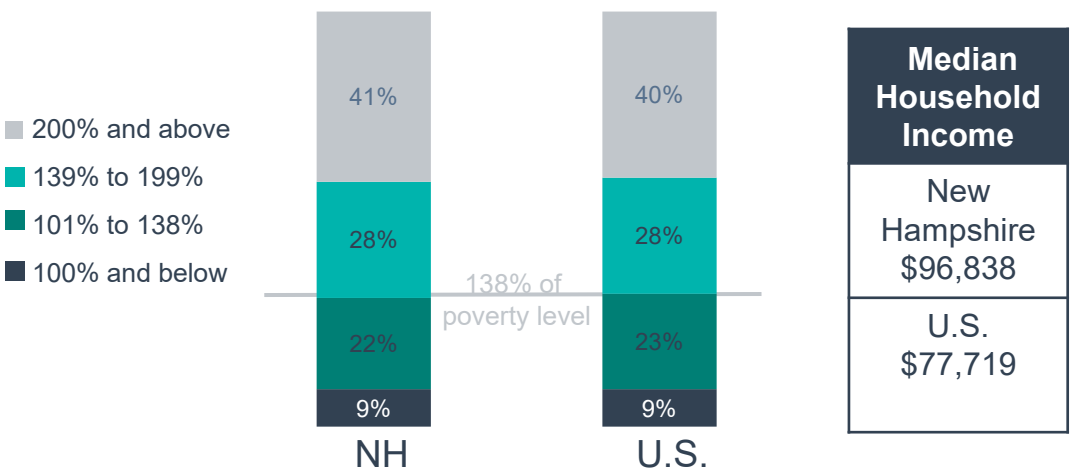

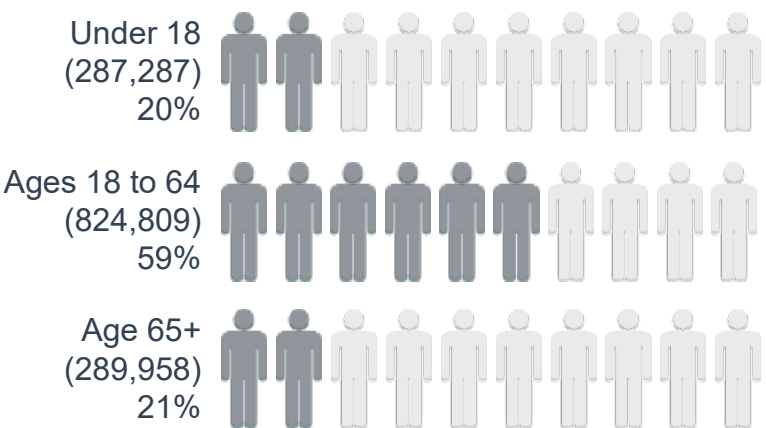

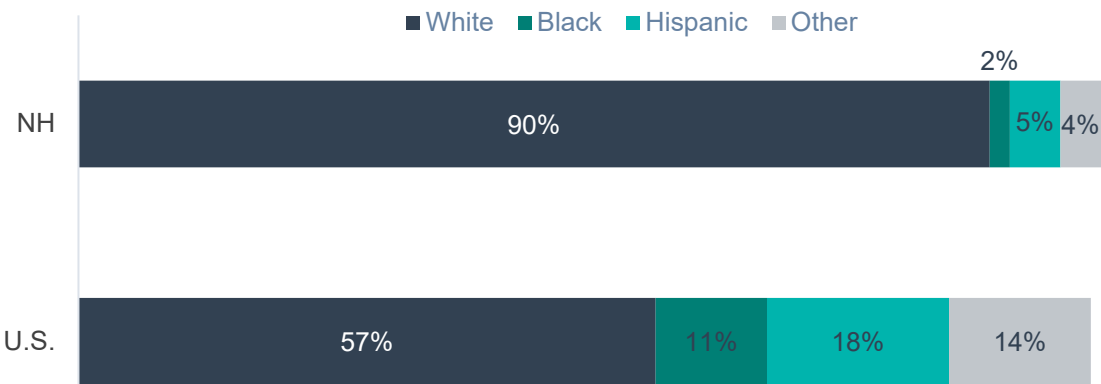
Population Distribution By Income To Poverty Threshold Ratio

New Hampshire & U.S. Racial Composition

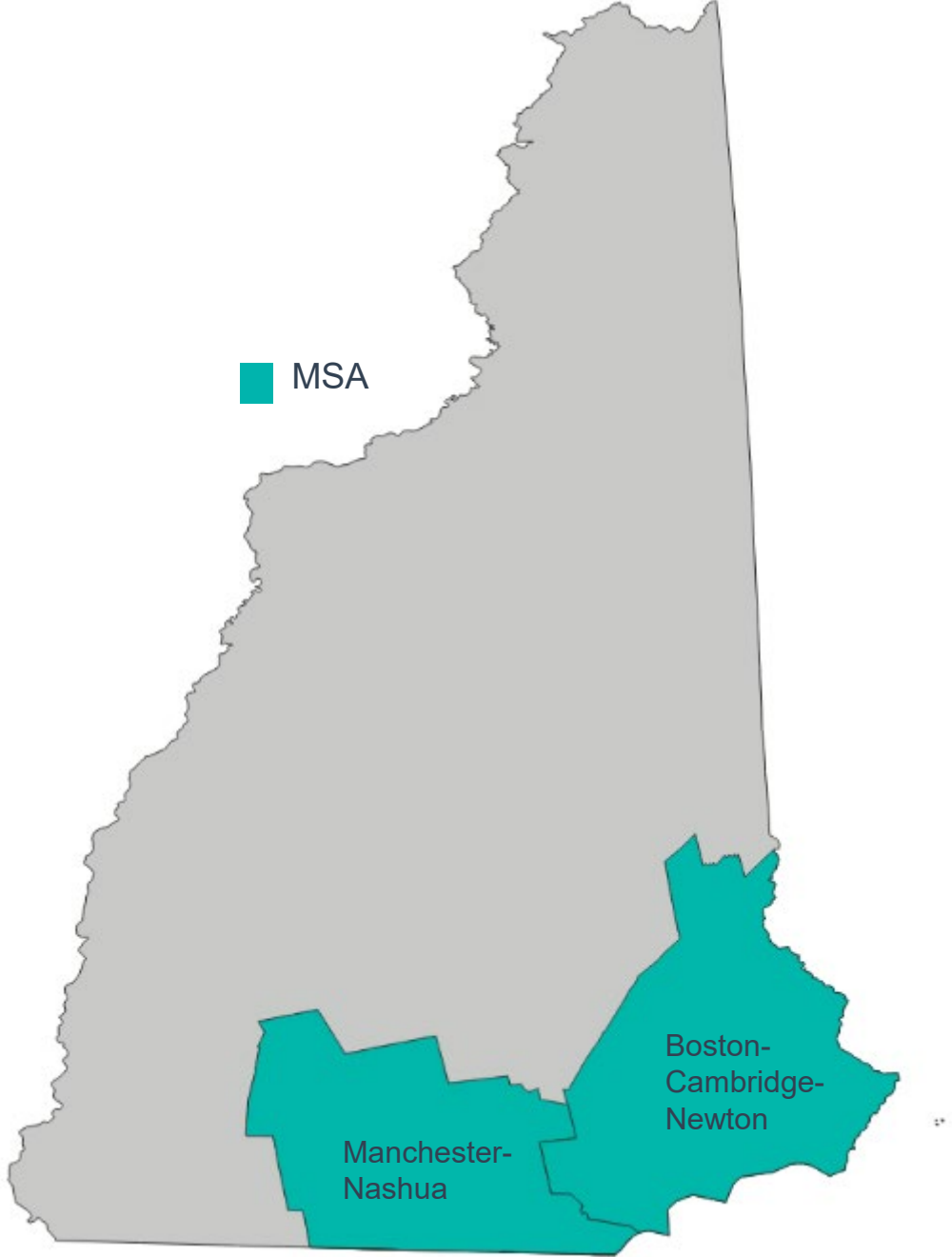

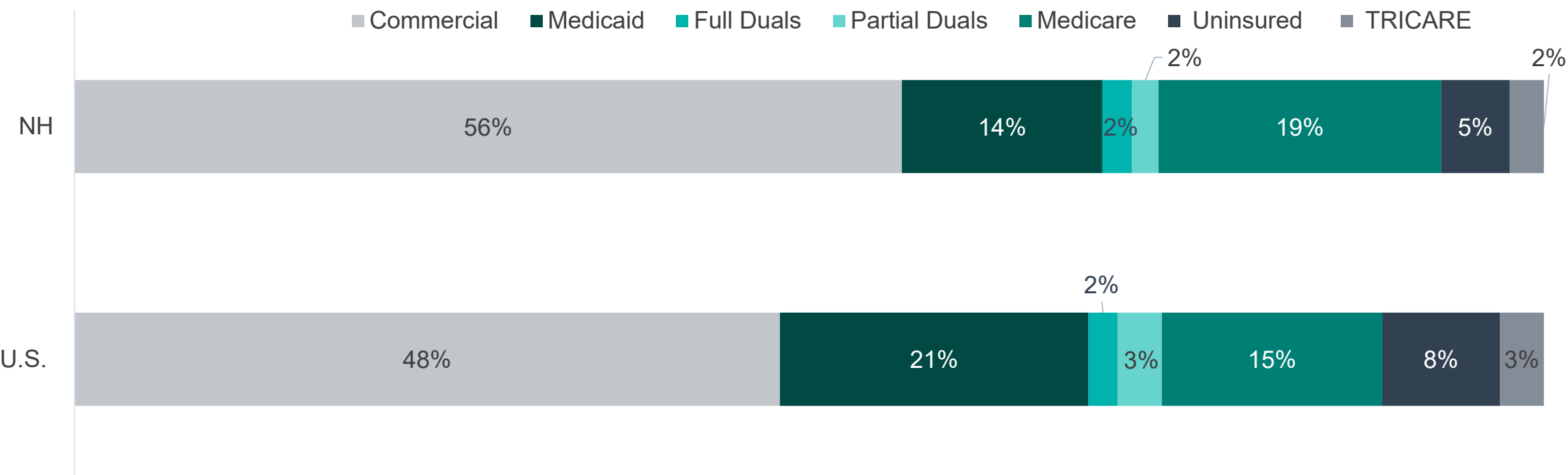

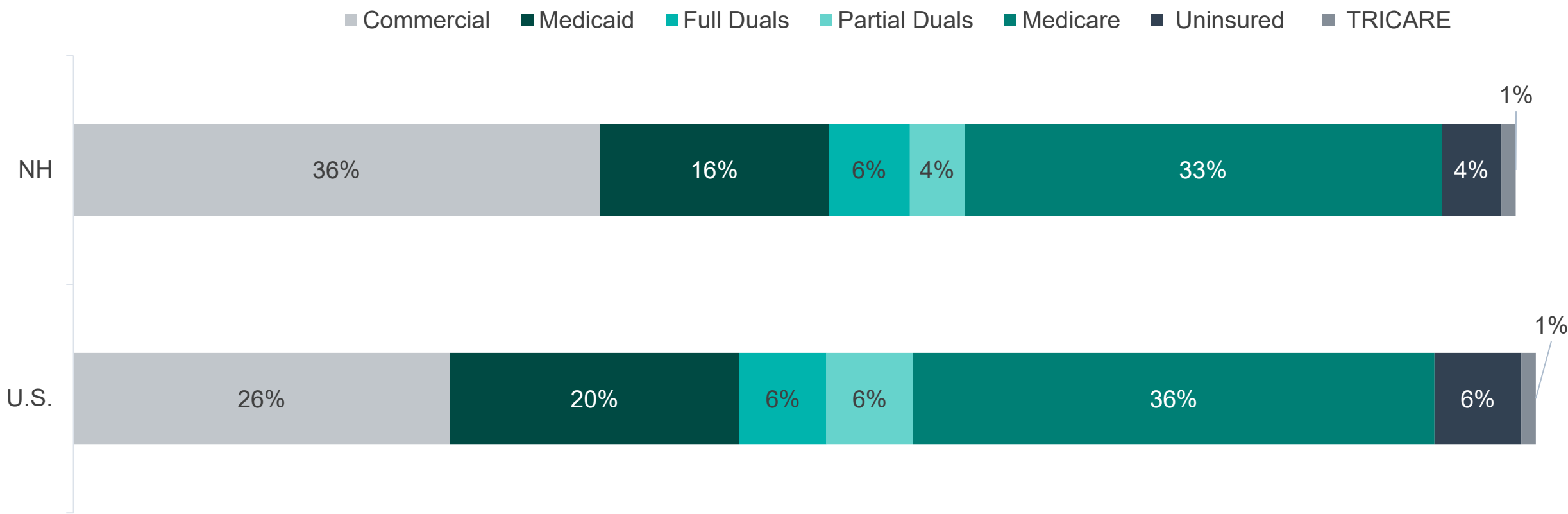

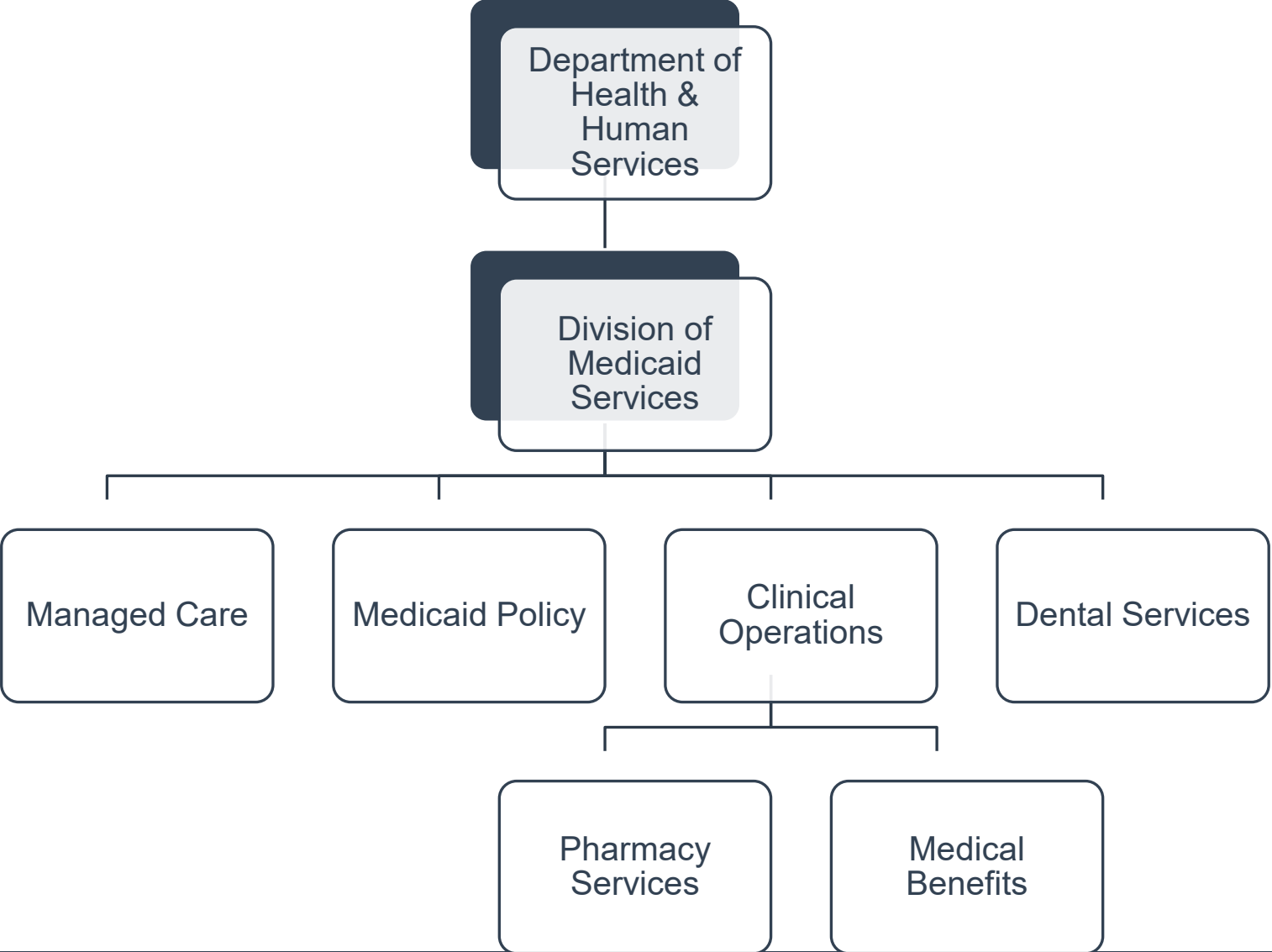

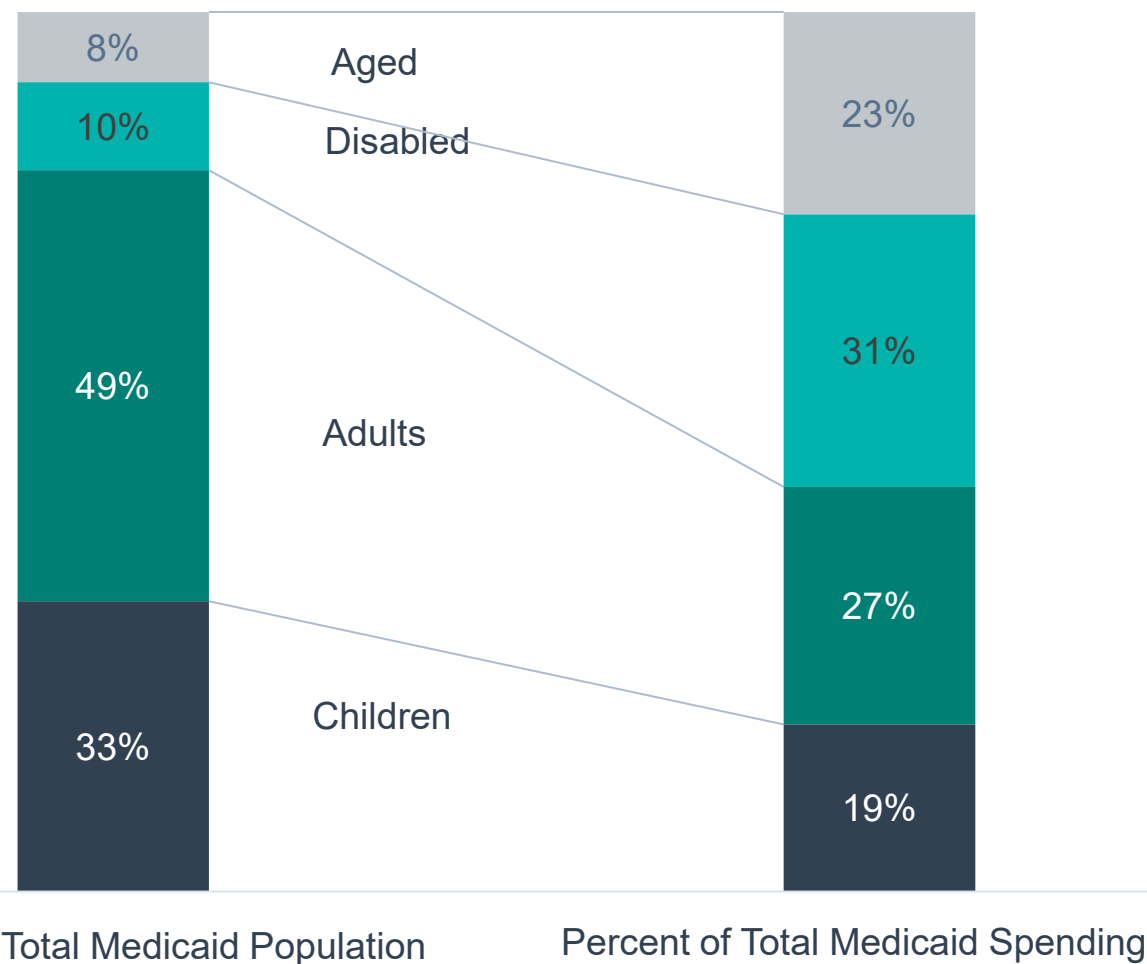
C.1. Medicaid Governance: Organization Chart

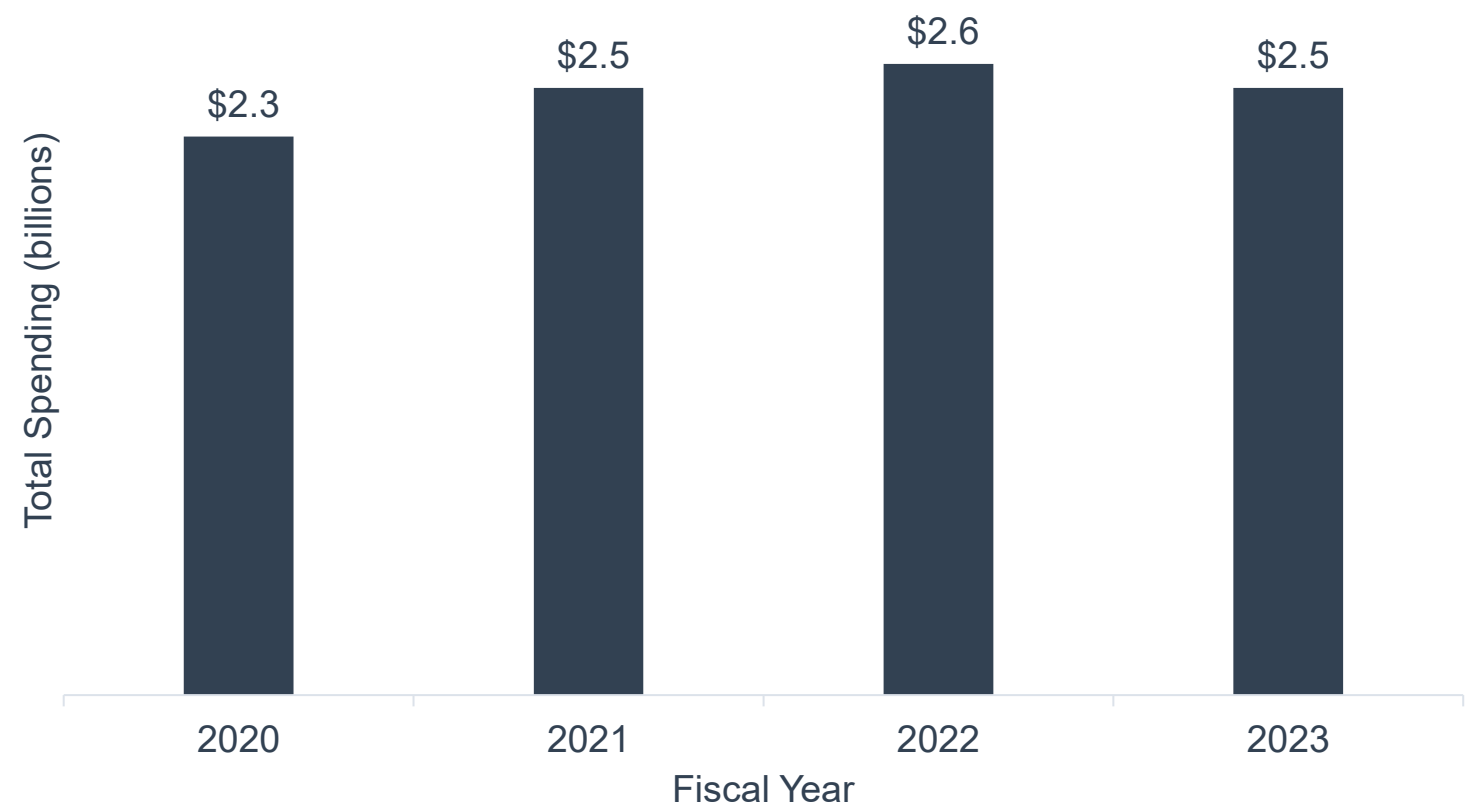

- New Hampshire has two managed care programs:
 - Medicaid Care Management (MCM)—Provides physical and behavioral health and pharmacy benefits to children, parent/caretaker relatives, individuals in foster care, and the aged, blind, and disabled population.
 - Granite Advantage—Under Granite Advantage, the Medicaid expansion population receives coverage through the Medicaid Care Management health plans.
- The managed care contract includes a requirement for the health plans to submit a payment reform plan to the state each year detailing its plan to engage provider organizations in innovative payment models, including pay-for-performance, shared savings, shared risk, and capitation.
- The program withholds 2% of the health plans capitation rate to ensure the health plans meet performance measures.
- The MCO's performance will be assessed in three performance categories: Quality Improvement, Care Management, and Behavioral Health.
 - DHHS will annually select performance measures, performance categories, and performance standards.
 - The behavioral health measures assess the percentage of members using CMHC program services that receive assertive community treatment (ACT) consistent with a fidelity score of 85 or higher; and the percentage of members in an emergency department or hospital setting awaiting psychiatric placement for 24 hours or more.

 - Required to contract with all willing peer recovery organizations and methadone clinics;
 - Offer enhanced reimbursement and develop alternative payment models for MAT;
 - Develop performance improvement projects for behavioral health;

- Medicare enrollment as of February 2025 was 348,616.
- It is estimated around 19% of the state's total population is enrolled in Medicare, compared with about 19.5% of the U.S. population enrolled in Medicare.
 - *OPEN MINDS* estimates approximately 23% of the state's SMI population is enrolled in a Medicare plan.
- Nationwide, more than 35%% of Medicare beneficiaries have Medicare Advantage plans. New Hampshire has 36% of the Medicare population with a Medicare Advantage plan.
 - Medicare Advantage plan availability varies by county, but residents in New Hampshire all have at least 20 plans from which to choose for 2025.
- There are 23 insurers in New Hampshire approved to offer Medigap plans in 2025.
- In New Hampshire as of September 2024, there were 149,872 people with stand-alone Part D prescription drug coverage. Another 110,046 beneficiaries of Medicare in New Hampshire had Medicare Part D prescription coverage as part of their Medicare Advantage plans.
 - There are 16 stand-alone Medicare Part D prescription drug plans in New Hampshire for 2025, with premiums starting at \$0 per month.
- Many Medicare beneficiaries receive financial assistance through Medicaid with the cost of Medicare premiums, prescription drug expenses, and services not covered by Medicare – such as long-term care.

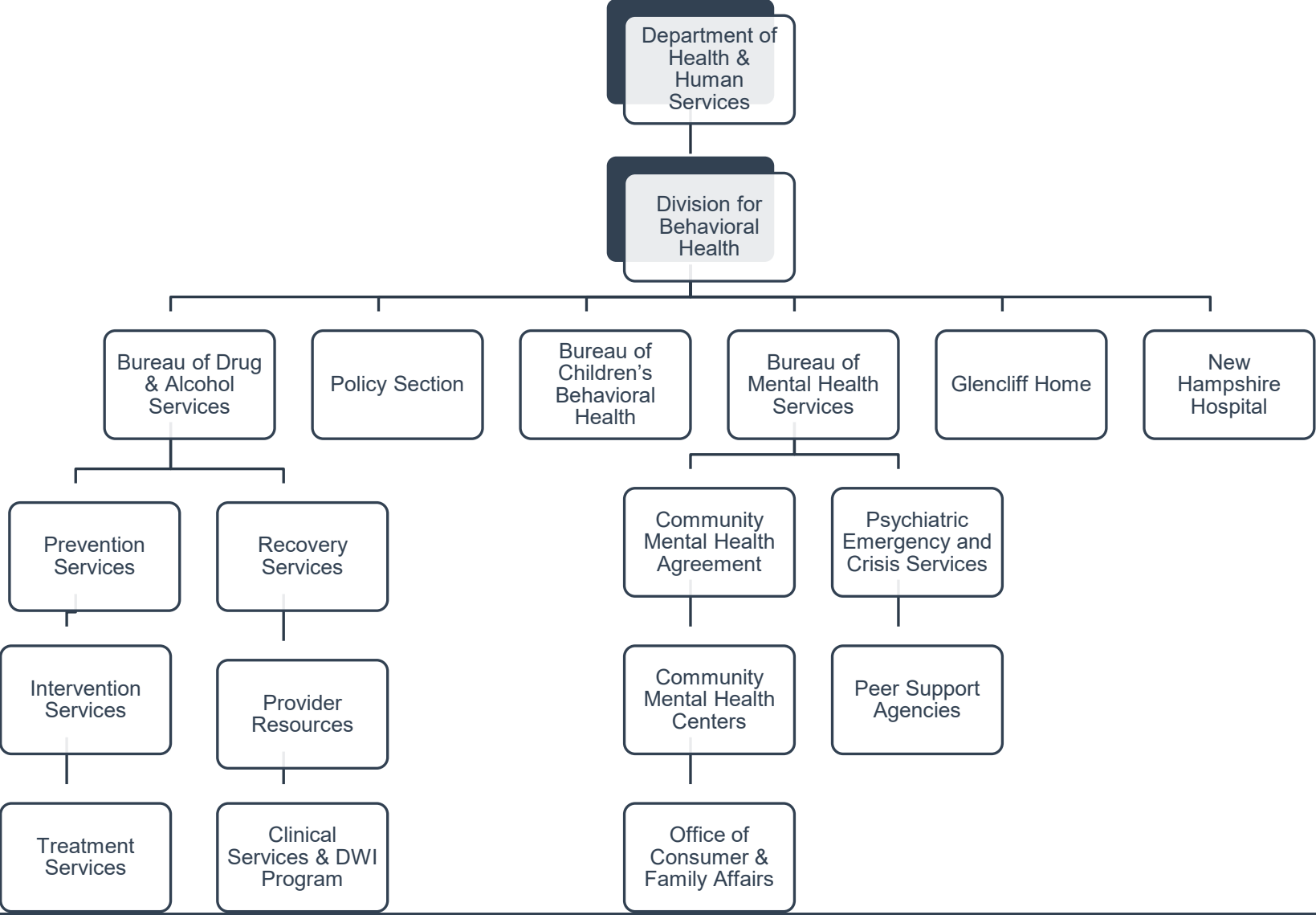

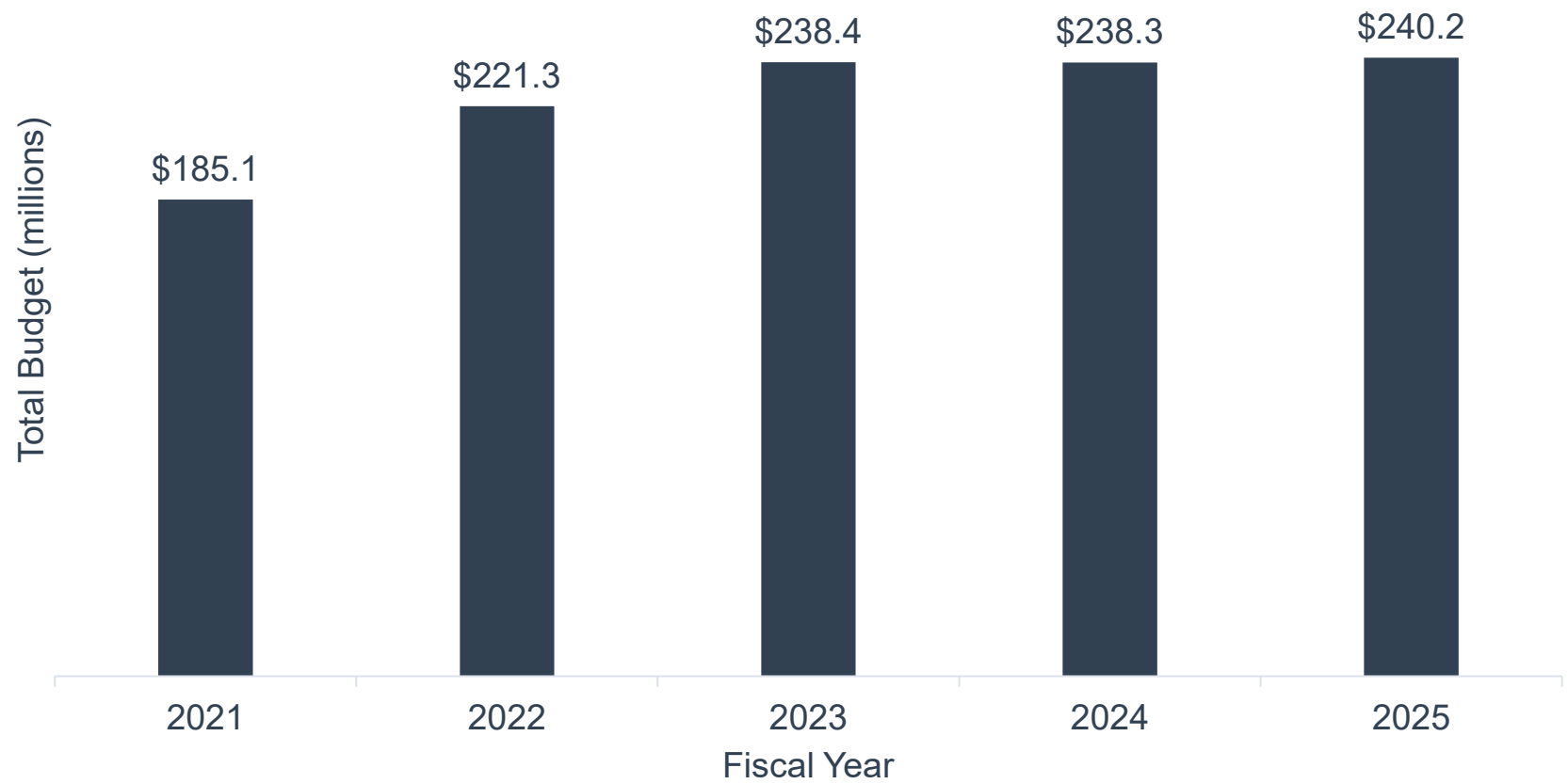

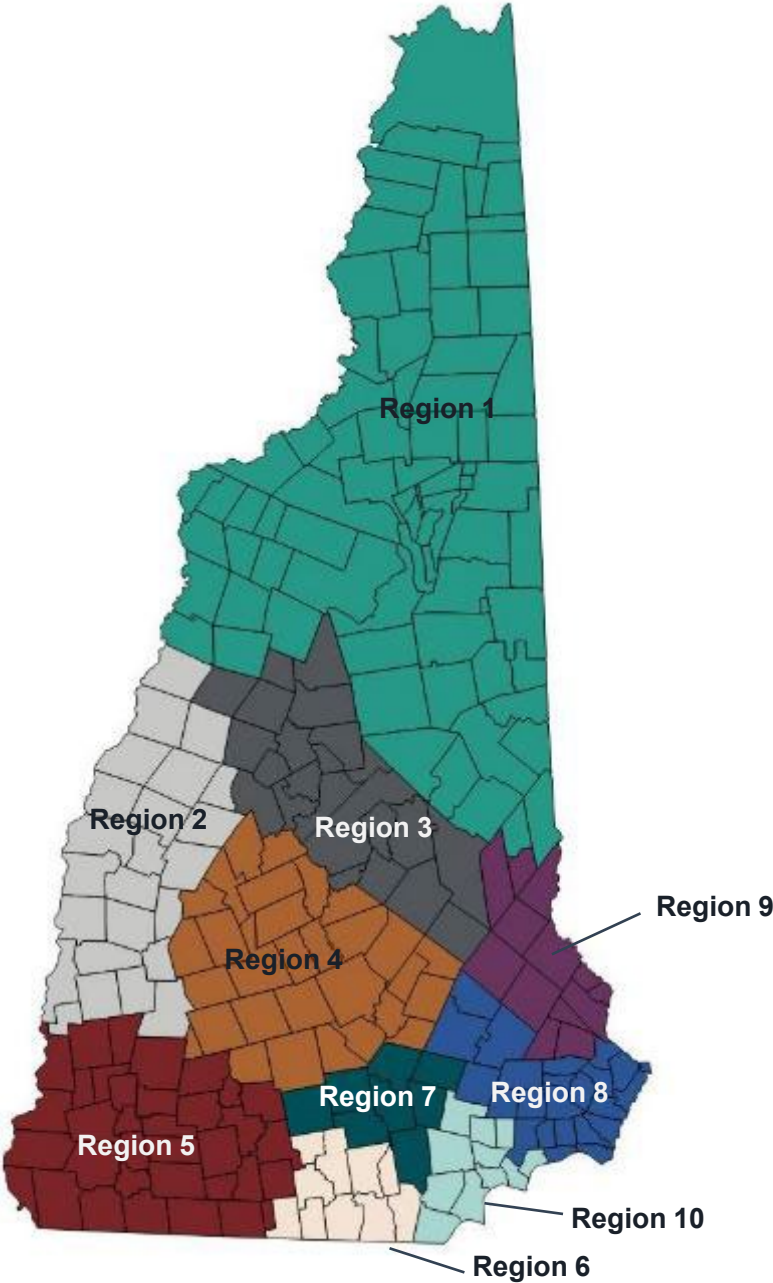

- The Division of Behavioral Health contracts with 10 private, non-profit agencies that act as community mental health centers (CMHCs), providing safety-net mental health services on a regional basis.
- CMHC services may be financed through a combination of state, federal, and third-party funds. The CMHCs serve Medicaid beneficiaries in addition to the uninsured population.
- CMHC services include:
 - Emergency services
 - Assessment and evaluation
 - Individual and group therapy
 - Case management
 - Community-based rehabilitation services
 - Psychiatric services
 - Community disaster mental health support
- The Division of Behavioral Health does not have an organized system for addiction disorder treatment. It provides funding to provider organizations to help individuals access addiction treatment services.

Value-Based Reimbursement	VBR	Reimbursement model in which payers financially reward or penalize health care provider organizations for performance on quality and cost of care. VBR payment mechanisms include P4P; capitation; shared savings models; shared risk models; and payments based on clinically-defined episodes, called episodes of care or bundled payments.
